TO PARENTS OF STUDENTS ATTENDING La Joya ISD:

Under the No Child Left Behind (NCLB) Act of 2001, a Title I, Part A-funded local education agency (LEA), or school district, that has not met AYP for two or more consecutive years in the same indicator (reading, mathematics, attendance rate, or graduation rate) is subject to LEA-level Title I School Improvement Requirements. Based on the 2010 LEA AYP Status released August 5, 2010, La Joya ISD is subject to the LEA-level School Improvement Program (SIP) requirements for Stage 1 for the during the 2010-2011 school year.
